# COUNCIL UP-DATES



## MESSAGE FROM THE MAYOR

Calling all wannabe pilots! We had an interesting meeting with representatives from Alkan Air on March 6th, to listen to their request for support for a project to train four Kaska members to be professional pilots. Lacia Kinner, Chief Operating Officer, for Alkan, and three senior Alkan staff members were here to fill us in on the Can-Nor/CDF funded project that would provide training here in Faro over a 14-month period to train four persons to becoming professional pilots. Faro was chosen as the preferred site because of both its airport and municipal services.

Given the Canada wide shortage of pilots, this is welcome news indeed. We asked Lacia if there could also be opportunities for other non-Kaska persons to receive training as well, separate from the NorCan funded project. The short answer is yes. Lacia thought this could be accommodated as well if sufficient interest was found. Interestingly, some of these training costs may also be eligible for EDF funding to support the cost instruction for both ground school and flight instruction. Follow-up is needed to see how this opportunity might be brought into fruition. We will keep you posted.

In other news of importance, council's been busy finalizing our departmental and capital budgets together with administration and our department heads. As of March 26th, we still have two more budget meetings scheduled to complete the process. The third reading of the bylaw to adopt our budget must be moved by no later than April 15th to meet the requirements of the municipal act, which I'm certain we will meet.

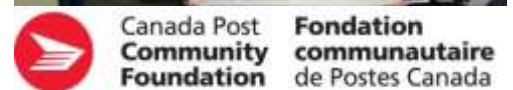
Other pressing issues we've been working on includes hopefully soon gaining both the YESAB and Water Board approvals for our new water supply well, which we plan to be drilling this spring, and as well finalizing the Phase II Sewer Replacement contract work with the Infrastructure Branch. Also in the works are the negotiations with YG for Faro to become one of eight Yukon regional landfills, which has been on YG's wish list for some time. We've clearly said that the Town of Faro would only agree to this if it were of some benefit to the town. We will keep you posted as all of these challenges are settled.

## Refresh: what is an OCP and why does it matter?

Municipal governments make decisions that impact the lives of residents daily.

Municipalities develop periodic OCPs which, along with the Zoning bylaw, set a vision and direction over the short and medium term.

- ◆ OCPs are arguably a municipal government's most important policy tool.
- ◆ Generally, all Town actions should go towards supporting the overall OCP goals.
- ◆ The OCP is the foundation of planning and development for the municipality.
- ◆ The planning horizon of an OCP document is typically 10 years.

This OCP process is being led by a team of independent consultants with guidance from Council. The consultant team includes Jordan Stackhouse of Elevator Yukon as the project lead in partnership with Denis Shewfelt Planning & Consulting, John Glynn-Morris as the public engagement lead, and Mammoth Geospatial for mapping and surveying.

## MESSAGE FROM THE CAO

### Why does it take SO long?

There is an old joke that government likes to cut the red tape ... lengthwise. Coming from a construction background myself, I fully understand the frustration when it can take SO long to get some things done.

I was reminded about that again this year when the Finance Department was preparing for an important new municipal auditing requirement. We had to research details about our recreation leases that we previously didn't have to worry about, and that's when we found out a few of those leases had actually expired. While the process to rejuvenate an old lease may be a bit faster, I was told all new land leases can now take up to 2 years to wind its' way through the many departments of the Yukon Government. (BTW: For those wonderful YG employees who do struggle to provide Faro with a timely response and assistance, God Bless You!)

If you regularly review the reports I provide to Council, you will note at any given time, we have many projects in process but sometimes I can only report I have no new information to report on that topic. Most often, it is because I am waiting for someone else to make a decision or confirm funding availability.

While the average citizen may feel Town decisions may take time, we are still faster and easier to deal with than our Territorial or Federal counterparts. Still, some of the rules we have to follow to get to a decision are not set by us. A good example is the Official Community Plan (OCP) process, which has timelines defined by the Yukon Municipal Act. Under normal conditions, developing an OCP will easily take a year or more because of all the required timelines and steps we have to follow.

That said, we are almost finished with the newest version of the OCP, and we are really pleased with how it is shaping up. This new OCP replaces a plan from 2015, and which was developed when Faro was struggling just to survive. In 2024, Faro is struggling again, but for very different and very positive reasons. Housing is a serious issue because the community is growing and people are looking for accommodation. Businesses are looking for commercial space. Contractors are looking for industrial property.

The OCP contains over 100 recommendations this, and future, Town Councils will need to be mindful about over the next 5 to 8 years. These recommendations cover topics like protecting our assets during a changing world climate; maintaining affordable service delivery; employment; economic development & tourism; housing & land development; recreation; emergency planning; water & wastewater infrastructure; and road systems.

Council will be hosting a public information session for people to view the DRAFT Official Community Plan, and we encourage everyone to take a few minutes to attend and review the plan being proposed. Mayor & Council look forward to your comments.

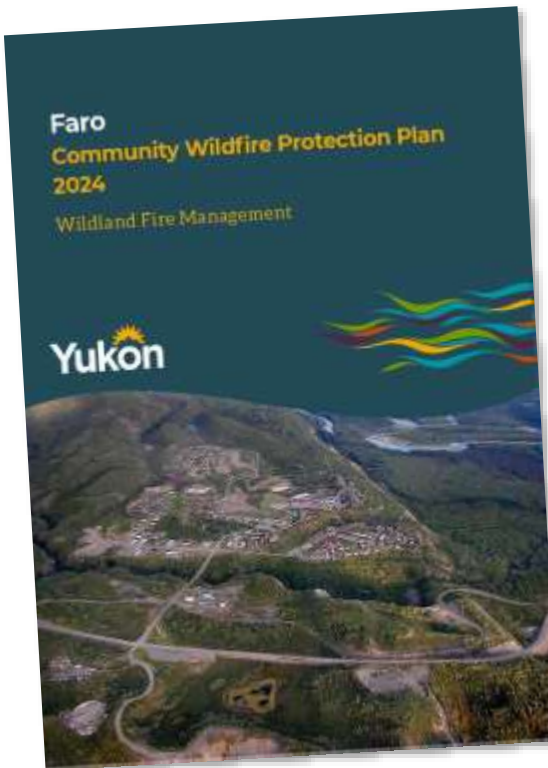

# 2024 COMMUNITY WILDFIRE PROTECTION PLAN

The Faro Community Wildfire Protection Plan (CWPP) was developed through a collaborative effort between the Town of Faro and the Government of Yukon Wildland Fire Management Branch. Ember Research Services Ltd and Forsite were contracted and provided significant contributions towards the technical assessments and recommendations herein, as well as the writing of the plan.

The CWPP addresses the wildland-urban interface (WUI) surrounding the community of Faro. The area of interest is within the traditional territory of the Ross River Dena Council.

Using the best available spatial data and fire science research, this CWPP identifies the wildfire risks surrounding the community, the potential consequences of a wildfire to the community, and recommends possible ways to reduce that risk. Although wildfire threats cannot be eliminated within the area of interest, this CWPP can significantly build on existing efforts to reduce the risk and potential impacts.



Focused on Faro

The recommendations are based on a review of best practices from other jurisdictions, gaps identified through community engagement, the local wildfire risk analysis, prevention of human-caused ignitions, and integration of FireSmart program principles.

Of 20 Action Items detailed in the CWPP, some of the highest priority recommendations include:

1. Community engagement: The public needs to know about the Plan.
2. Ongoing awareness: Conduct annual community meetings in support of the CWPP and community preparedness.
3. Promote FireSmart Principles.
4. Organize community clean-up days for properties. Prioritize properties based upon FireSmart Home Assessments done and proximity to forest fuels.
5. Organize Wildfire Preparedness Days in identified high risk areas, collaborate with Yukon Wildfire and local fire department.
6. Design a fuel management plan to reduce fuel loads in high coniferous areas, particularly conifers in the old burn scars.
7. Support community members to clean up vegetation in their Home Ignition Zone.
8. Pursue and coordinate cross training opportunities.

In the last few years, Yukoners have seen the devastation that wildland fires have wreaked across Canada. Often, by the time the danger is identified, it is often too late to do anything but evacuate. The 2024 Community Wildfire Protection Plan that has been developed for the Town of Faro, recognizes the problem areas and provides recommendations to reduce those risks. It also proposes training more people to work to protect our region.

# PUBLIC WORKS & OPERATIONS UP-DATES



## MESSAGE FROM THE OPERATIONS MANAGER

### Public Works Crew

Our Distribution Pump-house Backup Generator plans have changed. As we're required to have the unit placed outside of the building (Engineering code C282 for emergency backup generators). This will actually simplify the project considerably, but there is a 32 week lead time which is fine as we have many projects to do this spring/summer and we'll have everything ready for when the genset arrives.

We're waiting for final approvals from the regulator for our Water Well #5 Replacement Project which has completed the YESAB process with no conditions (rare event). Soon I hope to schedule drillers.

Other projects include cleaning up the power to our Water Treatment Plant, electrical upgrades to Well-house One and install a bleeder into this well as it has no frost protection and must run continuously all winter.

We'll be spending considerable time and effort this year preparing our streets for BST in the future.

The Town of Faro will be managing many of our projects with local workers and contractors. If this continues to prove successful, we'd like to project manage as much of our own infrastructure work as possible.

### Projects

Ladue Drive property update - Yukon Lands Branch has hired surveyors to replace missing property pins and Yukon Energy to do the power line installation. Ditching, culvert and driveway installation to be undertaken by Town of Faro. This work will likely all happen this spring to be ready for a sale later in the year.

Future property development may include Lower Douglass or Rose Crescent.

The Town of Faro has been developing a local Contractor List to as-

sist us in upcoming projects in collaboration with Yukon Govt or with our own projects. The Town of Faro will accept applicants throughout the year.

Construction of a new Animal Shelter will be starting in the spring.

### Community Services Building

The Fire Department has now moved in, but we are still waiting on some electrical work which is still outstanding. Manual Overhead Door overrides are installed on the Emergency Services side.

### Snow Removal

We're pulling snow off the streets now and hauling away to our snow dumps. Please be sure you haven't parked boats, trailers etc. in our snow dumps. Avoid parking on the streets, especially during the day. In some areas, particularly Douglass and Yates, we'll be pulling as much snow out of the ditches as possible to minimize damage from runoff once the melt starts.

## MONTHLY FIRE SAFETY TIP - Fire Safety for Rental Units

- ◆ All rental housing must have working smoke alarms and carbon monoxide detectors.
- ◆ Maintenance and installation of the smoke alarms is the responsibility of the landlord/property owner. Be sure to maintain the smoke alarm in accordance with the manufacturer's instructions.
- ◆ CO alarms should be installed in a central location outside each sleeping area and on every level of the home and in other loca-

tions where required by applicable laws, codes or standards. For the best protection, interconnect all CO alarms throughout the home. When one sounds, they all sound.

- ◆ Install smoke alarms in every sleeping room & outside each separate sleeping area, on every level of the home, and in the basement.

# MOSQUITO CONTROL PROGRAM PUBLIC INFORMATION

Initial surveying and monitoring for the annual Town of Faro Mosquito Control Program is scheduled to begin as early as the week of April, 8 2024. The consulting firm working with the Town in the management of mosquito populations is Duka Environmental Services Ltd., an environmental services firm with over 35 years of experience. All mosquito larvicide applications by Duka Ltd. and certified Faro public works personnel would be completed under Pesticide Service Permit # 21-004 (Duka) and Pesticide Use Permit # 22-008 (Faro).

The goal of the annual program is to reduce adult mosquito annoyance for residents and visitors. The best way to achieve this through effective control of larval mosquito populations. Control program efforts are focused on the identification and treatment of developing mosquito larvae using the biological larvicide VectoBac 200G (PCP #18158) containing the heat-killed bacterium,

*Bacillus thuringiensis* var. *isrealensis* (Bti). This product is specific in its control of mosquitos and biting flies. It has no effect of non-target insects, fish, birds, or mammals, including humans, livestock, and pets.

Larval development occurs with surface water accumulations from snowmelt and precipitation in shallow ponds, non-flowing ditches, depressions, and tire ruts. Proposed treatment dates are from 8 April 2024, through to early August 2024, depending on conditions. VectoBac 200G would be only applied when and where mosquito larvae are present.

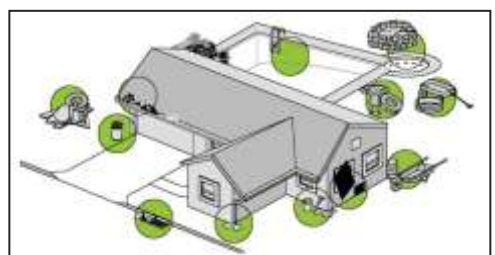
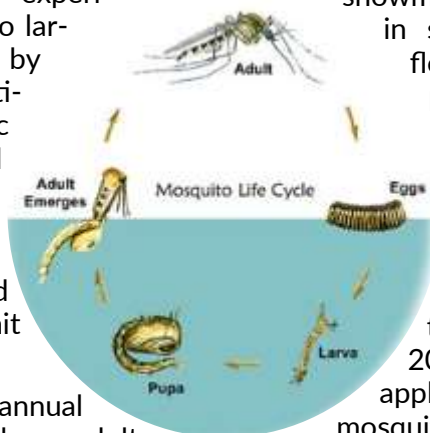
Treatment site locations are little changed from past seasons and all details are summarized for the Town of Faro and Yukon Environment in a summary report submitted by Duka Ltd. at season end.

While the larval mosquito control program will reduce overall mosquito populations, residents and

visitors should still be prepared to protect themselves from adult mosquitos by using repellents and wearing loose, light coloured clothing. Avoid perfumed skin care products and shampoos. Regularly drain and refill wading pools, livestock watering troughs and empty water-filled boats, tires, canoes, or other containers. Eliminate water-holding tire ruts and depressions.
